- 7) The waste papers given should be sent to factory for pulp making only for recycling purpose and should not be used for any other purposes. The selected vendor shall have to furnish an undertaking that the material will be sent to the factory for recycling / pulp making only and shall not be disposed of in any other manner. After recycling / pulp making a certificate to that effect is to be issued to The West Bengal State Co-operative Bank Ltd within 07 days of taking over the materials.
